VENDORS ARE JURIED, BEGINNING JULY 15 BY COMMITTEE UNTIL CATEGORIES ARE FULL. YOUR ENTRY FEE CHECK IS NOT CASHED UNTIL NOTIFICATION OF SELECTION. IF YOU ARE NOT ACCEPTED, YOUR CHECK WILL BE RETURNED TO YOU.

VENDORS ARE REQUIRED TO HAVE A RESALE LICENSE FROM THE STATE BOARD OF EQUALIZATION, AND ARE RESPONSIBLE FOR COLLECTING AND PAYING THEIR OWN SALES TAX. FALLBROOK'S TAX RATE IS 7.75%.

ALL ITEMS FOR SALE IN THE BOOTH MUST BE ORIGINAL HANDCRAFTED WORK CREATED AND PRODUCED BY THE ARTIST. IF YOU CREATE ITEMS IN MORE THAN ONE CATEGORY, PLEASE MAKE US AWARE OF ALL CATEGORIES YOU WILL PARTICIPATE IN (E.G., JEWELRY, PAINTINGS, CLOTHING, ETC.). SHOW US EXAMPLES OF EACH CATEGORY WITH PHOTOS OR LINKS TO YOUR ONLINE SHOP.

BEFORE AUGUST 31 – SINGLE VENDOR SPACE (10 X 10) - \$85.00 | AFTER SEPTEMBER 1 - \$100.00

VENDOR PROVIDES OWN WHITE 10 X 10 CANOPY, UMBRELLAS AND TABLES. YOU MAY APPLY AND PAY FOR TWO BOOTHS IF MORE SPACE IS REQUIRED.

NO ELECTRICITY WILL BE AVAILABLE AT THE BOOTHS. FOR SAFETY REASONS, NO DOGS ARE ALLOWED.

NO REFUNDS WILL BE GIVEN FOR INCLEMENT WEATHER, ACTS OF NATURE, OR RESTRICTIONS BY GOVERNMENT AGENCIES, OVER WHICH THE FALLBROOK CHAMBER OF COMMERCE HAS NO CONTROL.

**CANCELLATIONS:** Booth (Vendor) and/or event cancellations, for any reason, including inclement weather, acts of nature or restrictions, event cancellations by government agencies (including mandatory closures or recommended closures of event), over which the Fallbrook Chamber of Commerce has no control, received before 30 days of the event, are assessed a 25% cancellation fee per booth.
