

Parade Rules

**Failure to read and adhere to these rules
may result in removal from the line-up at any time**

1. All participants are required to follow current CDC guidelines at the time of the parade.
2. There will be only **ONE** Santa in the parade, and his appearance will be sponsored by the Chamber of Commerce. Other "Santas" will be removed before procession begins.
3. For safety, **NOTHING** (including candy) can be thrown into the crowd from the parade route. If this rule is broken you will be suspended and not able to participate in subsequent parades.
4. Entries must be in line in their respective staging areas by 4:00 p.m. The parade begins at 5:00 pm. **All participants must remain in their assigned space for the entirety of the event.**
5. Animal entries are required to supply their own "pooper scoops."
6. No commercial advertising other than commercial **SPONSOR** names.
7. **Political statements are prohibited.** Violators will be removed from the parade lineup.
8. No discharge of firearms or fireworks; no candles, smoke or incense of any kind may be used.
9. Entries may not make loud noises or have disruptive activities. This includes excessive use of sirens, very loud music, or any other sound that may disturb other entries nearby. Please be courteous in the staging area if you will have any sounds with your entry.
10. All floats should be constructed with noncombustible or flame-retardant materials.
11. Entries are **REQUIRED TO PRESENT A HOLIDAY THEME.** The Chamber of Commerce reserves the sole right to turn away any unit deemed not in keeping with the holiday spirit prior to, or during, the parade. **PLEASE DECORATE YOUR ENTRY AND USE LIGHTS IF YOU CAN!**
