Parade Rules

Failure to read and adhere to these rules may result in removal from the line-up at any time

- 1. All participants are required to follow current CDC guidelines at time of parade.
- 2. There will be only ONE Santa in the parade, and his appearance will be sponsored by the Chamber of Commerce. Any other "Santa" will be removed before parade begins.
- 3. For safety, NOTHING (including candy) may be distributed or tossed to the passing cars from your parade space.
- 4. Entries must be in line in their respective staging areas by 4:00 p.m. The parade begins at 5:00 p.m. and ends at 6:30 p.m.

All participants must remain in the assigned space for the entirety of the event.

- 5. Animal entries are required to supply their own "pooper scoops."
- 6. No commercial advertising other than commercial sponsor names.
- 7. No discharge of firearms or fireworks; no candles, smoke or incense of any kind may be used.
- 8. Entries may not make loud noises or have disruptive activities. This includes excessive use of sirens, very loud music, or any other sound that may disturb other entries nearby. Please be courteous in the staging area.
- 10. All floats should be constructed with noncombustible or flame retardant materials.
- 11. Entries are **REQUIRED TO PRESENT A HOLIDAY THEME**. The Chamber of Commerce reserves the sole right to turn away any unit deemed not in keeping with the holiday spirit prior to, or during, the parade.
